Topic: Auditing as a tool for Managerial Decisions

The Webinar was conducted by the Department of Commerce and Business Administration on 10.7.2021 between 11.00 AM to 12.00 PM.

The speaker shared his thoughts on different types of Audits and the importance of Audits in the effectiveness of every organisation irrespective of the size and scale of operations. Management audit seeks to evaluate whether a company has a suitable organization and appropriate management team in place to achieve its objectives. It focuses on strategic objectives and enables a company to adapt its key human resources to the changing business environment.

He opined that the purpose of a management audit is not to appraise individual executive performance but to evaluate the management team in its effectiveness to work in the interests of all the stakeholders, maintain good relations with the employees, and uphold reputational standards.

While speaking on the importance of Management audit in organisations, the speaker told that reports on matters of policies and their implementation is very important to improve the efficiency of the management. Management Auditors advise the management on various matters related to performance of various departments as well as of the organization as a whole. Management Auditors may or may not be any finance and accountancy person. Management Auditors evaluate the actual performance by comparing it with predetermined standards.

Auditors reveal any kind of defect and irregularities in the working of management. It can be said management audit helps in improving the performance and efficiency of management.

Prof.Satyanarayana, Dean, Dept of Commerce and Business administration addressed the resource persons and other participants. Dr.Jyothi A.N welcomed the session and Vijeth J.K gave the validatory speech. Around 95 students of commerce and business administration stream participated in the webinar.

REPORT ON MUSHROOM CULTIVATION WORKSHOP

Mushrooms, often referred to the fruiting body of the gill fungi, are frequently mentioned as alternative source of food. In the present circumstances popularizing mushroom as a part and parcel of everyday food is of paramount importance. Mushroom farming is becoming successful because of its low inputs. It was calculated that approximately 317 million metric tones of fresh mushrooms could be produced annually that would provide 197g of fresh mushroom daily to each person in the world.

With this point of view, Department of Botany, Sarada Vilas College, Mysuru had organized one day workshop on "Mushroom Cultivation" for students as a part of their curriculum. The workshop was conducted on 27th January 2022 in the AV Hall. The workshop was inaugurated by Dr. Ashok N. Pyati, Asst. Professor, Department of Botany, Maharani's Science College for Women, Mysuru and presided by Dr. Devika. M, Principal and Head of the Department of Botany.

Workshop began with formal welcome note and inauguration. The workshop was of two sessions, the first session was the lecture on mushroom cultivation. The resource person covered various topics such as: types of edible mushroom and their nutritional importance, difference between edible and poisonous mushrooms, he also gave an idea of identification techniques for edible and poisonous mushrooms, and he spoke about the basic infrastructure and financial requirements for a beginner in mushroom cultivation and also about hurdles in mushroom farming.

The second session was hands on experience of mushroom cultivation, where the resource person demonstrated the method of cultivating Oyster mushroom using paddy straw as a substrate. He also made the students to get involved in the practical session of mushroom cultivation, where students

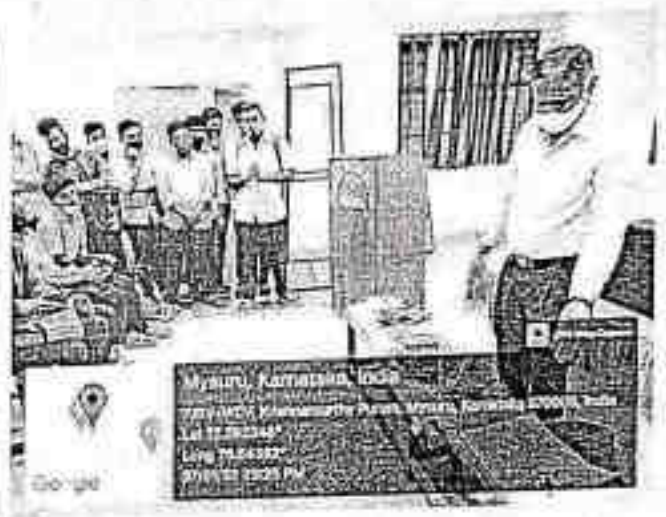

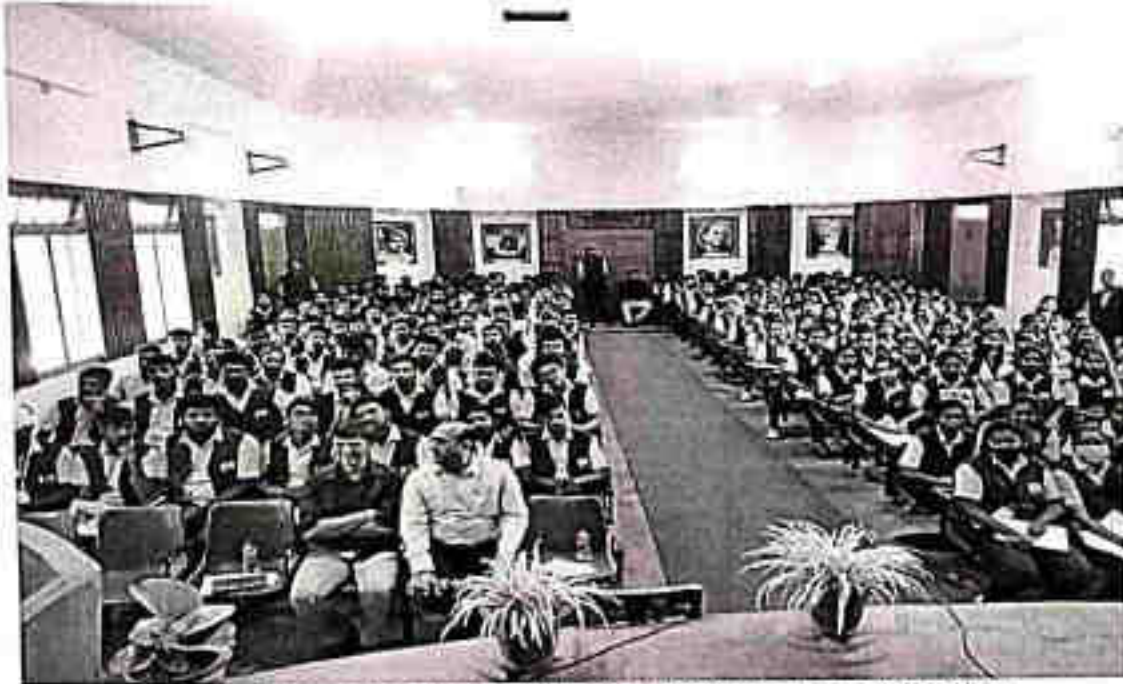

A special lecture on intellectual Property Rights: Patents, was conducted by Department of Microbiology and Biotechnology in association with IQAC, Sarada Vilas College, Mysuru on 18/06/2022 at A.V. Hall. Over 65 participants attended the special lecture. Participants and the guest of honour were welcomed by Dr. Manasa Ravindra Walmiki at 11.30 am, followed by initial remarks from Dr. M Devika, Principal, Sarada Vilas College. During her inaugural address Principal, Dr. M Devika stressed the importance of IPR and its relevance in these times and its necessity for the advancement in research and development in India. Guest speaker Mrs. Sunethra Dereball (Senior IP Specialist, OTT, C-CAMP, GKVK Campus, Bangalore) presided over the session, who spoke on the topic of "Patents - Procedural and Legal Aspects". Her lecture started with an introduction to Intellectual Property Laws and spanned across the different disciplines related to patents and patent filing. She pointed out that IPR is no more confined to the legal fraternity, but has spread across all disciplines because of which it has an impact and significance on arts, science, commerce, management and business. IPR have great significance not only in the uplifting the knowledge economy but also in fine-tuning it. She elucidated the meaning of intellectual use of traditional knowledge with an example of basmati rice case of 1997. She explained how to file a patent in India itself with respect to life science, biotechnology, computer science and physical sciences and also in the context of collaboration research. She briefed on IPR laws in different countries like USA, Germany, UK etc. She concluded the talk by explaining the rationale of protection and the nature of IPR. The session was concluded at 12.30 pm followed by interaction with participants and vote of thanks by Ms. Monica (2nd Sem, BtBc, SVC). The Special lecture was highly informative to students and teachers from other departments. Thus webinar provided valuable awareness and insights on the various aspects of IPR.

VBSC 451 Immunotoxicology of Drugs and Chemicals (Coordinator & Instructor: Dr. Prabhu) (Fa semester; 3 Credits)

The immunotoxicology course focuses primarily on the effects of environmental chemicals, therapeutics, and recreational drugs on the immune system. Immunomodulatory mechanisms are examined at systemic, cellular and molecular levels. Discussions include theory, principles, and methodology and key issues in immunotoxicology. (3 Credits)

VBSC 438 Introduction to Molecular Pharmacology (Coordinator: Dr. Adam Glick/Co-instructor: Dr. Prabhu) (Sp Semester; 3 Credits)

Molecular interactions between drugs and their tissue receptors and possible modifications of drugs to target different receptors will be discussed. Drugs used to treat infectious disease, cardiovascular disease, immune modulators, and anti-cancer drugs will be examined for their molecular interactions. Students will understand the complexities of new drug design and development from the initial stages of laboratory development to final approval for use by the Food and Drug Administration. (3 Credits)

VBSC 514 (NUTRN 514) Prostaglandins and Leukotrienes (Alternate Sp semester; Coordinator: Dr. Prabhu; 3 Credits)

The course provides an in-depth coverage of how fatty acids are metabolized in eukaryotes by various enzymatic and non-enzymatic mechanisms. The course will emphasize on the physiological roles of these fatty acid oxidation products in general health, inflammation, and reproduction along with their cellular basis of action via receptor-dependent and -independent mechanisms. (3 Credits)

1. Effect of selenium on leukemia stem cells.
2. Targeting leukemia using novel lipid mediators derived from n-3 and n-6 fatty acids.
3. Redox-dependent metabolomic changes in immune cells and its relevance in resolution of inflammation.
4. Effect of selenium and selenoproteins on gut inflammation with an emphasis on eicosanoid metabolism and macrophage polarization.
5. Effect of host selenoproteins in helminth infection.
6. Redox regulation of erythropoiesis.

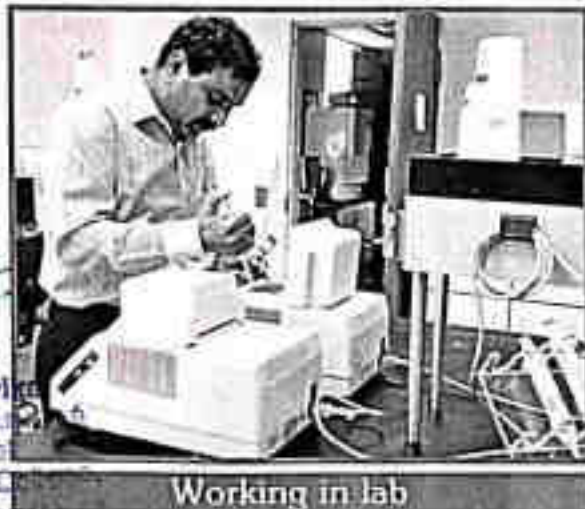

Research and other Contributions

1. Products:

Product 1: Improving the plant physiological metabolism:

- An organic plant tonic, PHYTON-T, formulated by him has been able to increase the yield and quality by manifolds in various crops.
- It does so by increasing the root mass, number & size of leaves and the chlorophyll content per unit area.
- The product has been tested and recommended by University of Agricultural Sciences, Bangalore
- New concepts have been successfully introduced in solving the 'hard to control' disease problems in important crops like root rot and wilt diseases of banana, black pepper, pomegranate, tobacco, etc.

Product 2: Virus disease management:

 - The product is already commercialized, and simultaneously being tested by premier institutes and universities.
